


# My Project: Humans Impact the World of Birds

- Government laws that protect birds.




# Human Societies are Impacting Birds

- Humans are moving and building in places they have never lived or built there.
- Some people are also just taking into account only what they want. An example is that people want housing developments in areas where there is habitat for birds.
- Cats are one of the biggest problems to birds when they are let outside.



### Human Structures are impacting the Environment and Birds

- Humans are building wind turbines all over the place.
   Wind turbines can be very dangerous to birds.
- Windows and glass on buildings can be very dangerous to birds.
- It is also dangerous to have lights on at night that are visible through a window because birds see the light and then they run straight into the window.



### Government Laws That Protect Birds

- The Migratory Bird Treaty Act is a law that protects all migratory birds in the USA, but some politicians want to take down the Migratory Bird Treaty Act.
- The Endangered Species Act protects all animals in the U.S. including birds.
- Recently a federal judge said that the MBTA couldn't be changed or weakened.
  Earlier this year some politicians wanted to weaken the MBTA.
- The Piping Plover is an endangered bird that lives across the Great Lakes and eastern US.





# My Plan to Help Save Birds!

I have had many ideas of ways to help save birds. This is one of them.

I have created a door hanger that has information about cats killing birds and why cats should be kept inside.

- A cat can kill up to 20 birds in a day if it is let outside.
- Outdoor cats kill 2.4 billion birds a year in the US alone.
- Outdoor cats are at risk of exposure, poison from eating rats, and car accidents.

- First of all, keep your cat indoors. In the U.S. alone, they kill 2.4 billion birds every year!
- Spread the news by mouth. Let other people know what's going on with birds.
- Pay for bird friendly windows or put up decals over your windows. Many birds die from running into windows because they think it's the sky or a tree.
- And last but not least, volunteer, advocate and donate to organizations that help birds.







## Bird Friendly Windows

The picture below shows what non-bird friendly glass and bird friendly glass looks like. On the bird friendly glass, the birds can see the lines so they don't think it's the sky or a tree and accidentally run into the window.



### Bird-Friendly Wind Turbines

A bird friendly wind turbine doesn't have blades and it also has a light on during the night so birds can see where it is.
